iCIMS Modern Slavery Act Compliance Statement for 2022

Overview

iCIMS is committed to being a responsible corporate citizen and mitigating risks of Modern Slavery in our workplace and our supply chain. To that end, iCIMS is committed to complying with all applicable Modern Slavery laws.

The Modern Slavery Act (“**MSA**”) was passed in the United Kingdom in 2015 to combat slavery, servitude, forced or compulsory labor, human trafficking, and child labor (“**Modern Slavery**”). Section 54 of the MSA requires that corporations be transparent in their efforts to ensure that Modern Slavery crimes are not being committed in their business and supply chains. iCIMS is committed to these principles and we support the efforts of the MSA against Modern Slavery.

Structure

iCIMS, Inc. and its subsidiaries (“**iCIMS**”) have employees primarily in North America, Europe, and Asia, and are committed to complying with measures addressing Modern Slavery in all jurisdictions where iCIMS has employees.

As a provider of software for the entire talent acquisition lifecycle, iCIMS does not have a supply chain in the traditional sense. However, iCIMS does engage with business partners, service providers, vendors, and other third parties to support our business and the iCIMS Talent Cloud platform. iCIMS is committed to treating all individuals with respect and dignity in alignment with our values and commitments to ensure that we operate as a responsible corporate citizen.

Policies

iCIMS maintains internal policies, processes, and guidelines that outline our dedication to ethical corporate conduct, which includes Modern Slavery, conflicts of interest, anti-retaliation, anti-corruption/anti-bribery, and anti-harassment. iCIMS opposes all forms of Modern Slavery and encourages our workforce to report all misconduct, including Modern Slavery.

To ensure all iCIMS personnel understand iCIMS’ commitment to ethical business operations from the moment of hire, iCIMS has embedded our corporate ethics policy directly into our Employee Handbook and our [Code of Conduct](#). iCIMS will continue to train and promote awareness for all our employees on Modern Slavery risks.

Due diligence

iCIMS is dedicated to assessing our business partners, service providers, and vendors to ensure that their commitment to opposing Modern Slavery matches iCIMS. We perform these assessments to ensure that our business partners, service providers, and vendors are committed to ethical business practices and combatting Modern Slavery in their own supply chains. iCIMS will also investigate and, if necessary, act on any allegations of misconduct within its supply chain. Risk

As a provider of software for the entire talent acquisition lifecycle, iCIMS does not have a supply chain for physical goods for the products and services we offer. We do, however, engage with other business partners, service providers, vendors, and other third parties to support our business and the iCIMS Talent Cloud platform. We will continue to work with our business partners, service providers, and vendors to achieve our goals of minimizing Modern Slavery risks and complying with applicable human rights and employment laws.

With respect to iCIMS' facilities and office equipment providers, we contract with firms and entities that we expect have similar goals and commitments to us and align with iCIMS' efforts to oppose Modern Slavery. We will also continue to regularly assess our business partners, service providers, and vendors to ensure alignment with iCIMS' commitments and goals.

Key performance indicators (KPIs)

iCIMS will assess the effectiveness of our efforts to prevent Modern Slavery within our business and supply chains by tracking and monitoring (i) the complaints or concerns reported to iCIMS regarding suspected violations of the MSA by our business partners, service providers, or vendors, and (ii) contractual obligations to ensure that iCIMS business partners, service providers, and vendors comply with applicable Modern Slavery requirements.
